### A. Citizen/Customer Comments

Mr. Hansen expressed his opinion on the mask policy currently in place for the fitness room due to COVID-19.

Mr. Hill addressed his concerns by explaining why the policy is in place and the Board requested Mr. Hill follow up with Mr. Hansen after the new Health Guidelines are released on the 22<sup>nd</sup> of January by the State.

### **B. Board District Representation Reports – Trustees**

 The Board members received an email with questions regarding the Group Fitness classes and proposed changes to the program. Mr. Hill and Mr. Hallmark also received the same letters and emails regarding these changes and have responded to the questions.

### C. Aquatics Report – Macie Burrill

• A little recap of 2020 Aquatics. We taught 1889 swimming lessons, and 731 kids participated in Pre Comp. We ended the year with 187 swimmers on our CHAT team. We taught 81 new lifeguards, 30 new instructors, and 12 CPR/First Aid certifications. We had 79 players participate in our Water polo programs. We held Water polo clinics and had 103 players participate. We were able to keep the outdoor pool open until November for our lap swimmers, Water Polo, and Swim Teams. We employed 140 lifeguards and 35 instructors over the summer, and have had a fantastic staff continue on this Fall and Winter. The water aerobics program is still going, even with Covid-19 we were able to hold classes that were well attended. Overall very successful

- year for Aquatics, even with 3 months in limbo. We really thought out of the box this year, and tried new ways for literally everything we did. A very successful year!!
- Swim lessons and Pre Comp started back up January 4 after a much needed holiday break. We are currently holding 2 Pre Comp sessions due to high demand – one at 4pm and another at 6pm. Swimming Lessons are starting off strong, with 126 in this first session.
- CHAT has been holding monthly inter-squad meets, keeping things here at our home pool.
- Water Polo is holding clinics and practices leading up to our season this March. We will start orange sales at the end of the month. We look forward to a parents meeting here soon, and a great season.
- Brighton High Region meet will be held on February 5<sup>th</sup> at South Davis Recreation Center. The 5A State Championship will be held at BYU on February 19<sup>th</sup> and 20<sup>th</sup>.
