NOTICE OF PROPOSED TAX INCREASE-COTTONWOOD HEIGHTS PARKS AND RECREATION SERVICE AREA is proposing to increase its property tax revenue. The COTTONWOOD HEIGHTS PARKS AND RECREATION SERVICE AREA tax on a \$678,000 residence would increase from \$217.40 to \$278.57, which is \$61.17 per year. The COTTONWOOD HEIGHTS PARKS AND RECREATION SERVICE AREA tax on a \$678,000 business would increase from \$395.27 to \$506.48, which is \$111.21 per year.

If the proposed budget is approved, COTTONWOOD HEIGHTS PARKS AND RECREATION SERVICE AREA would increase its property tax budgeted revenue by 28.14% above last year's property tax budgeted revenue excluding new growth.

All concerned citizens are invited to attend a public hearing on the tax increase.
